# **BARSO Cleaning Oil No. 553**

**Application range** For cleaning solid wood, multiplex and OSB treated with LIVOS oils. Not suitable for plywood and veneer.

**Technical qualities** Complies with German Industrial Norm (DIN) 53 160, fast to perspiration and saliva. Suitable for toys

according to DIN EN 71 Part 3. Free of organic chemical compounds according to DIN EN 71 part 9.

**Full declaration** Linseed oil, linseed oil — stand oil — natural resin ester, linseed oil — stand oil, linseed oil — wood oil -

stand oil, natural resin glycerol ester, orange oil, isoaliphates, silicic acid, micronized wax, dehydrated

amino sugar and drying agents free of lead (Ca, Mn, Zr).

**Color** Clear

**Dilution** Ready to use.

**Application method** With sanding fleece or polishing machine + cotton cloth, at temperatures above 12 °C (ca. 54 °F).

**Coverage** Depending on degree of soiling.

Clean equipment immediately after use with SVALOS Thinner No. 222 or LEVO Brush Cleaner No. 997.

Drying time At 23 °C (73 °F) and 50% relative humidity: 24 hours intermediate drying between cleaning with BARSO

Cleaning Oil No. 553 and subsequent care with the respective initial treatment product. At lower temperatures and higher humidity, please consider longer drying times.

**Specific gravity** Approximately 0.85 g/ml.

Safety advice Ensure good ventilation during and after application. Always be sure to store and then dispose cleaning

cloths, polishing pads, sponges, etc. that are still wet or even slightly moist with BARSO Cleaning Oil No. 553 in an airtight metal container or in water, as there is a danger of spontaneous combustion caused by

the plant oil content. The liquid or applied product is not self-ignitable.

P301+P310 IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Immediately call a doctor.

EUH208 Contains orange oil (limonene). Can cause allergic reactions.

**Storage** Cool and dry. Shelf life: unopened at least 4 years. Opened products react with oxygen, over time skin

formation and rancid smell can occur. Residues should be transferred into smaller containers.

### How to use

## **BARSO Cleaning Oil No. 553**

### Application/Oil wash

#### Floors:

Remove any skin that may be present in opened containers, then stir well.

Apply approx. 2 tablespoons of BARSO Cleaning Oil No. 553 to the floor. Then work in the oil with the polishing machine and a purple or black pad until the dirt is loosened. The BARSO Cleaning Oil must not be allowed to dry. If necessary, apply a little more oil. Then place a cotton cloth under the pad and absorb the soiled oil. Allow to dry for 24 hours. Subsequent care with KUNOS Natural Oil Sealer No. 244 or with the respective initial treatment product.

#### Worktops, furniture surfaces, etc.:

Remove any skin that may be present in opened containers, then stir well.

Apply approx. 2 tablespoons of BARSO Cleaning Oil No. 553 to the surface. Then work in the oil with an abrasive fleece until the dirt is loosened. The BARSO Cleaning Oil must not be allowed to dry. If necessary, apply a little more oil. Then remove the soiled oil with a cotton cloth. Allow to dry for 24 hours. Subsequent care with KUNOS Countertop Oil No. 243 or with the respective initial treatment product.

#### **Important tips**

In the case of colored surfaces pre-treated with LIVOS products, the effect shall be tested on an inconspicuous area.

It is possible that the colored layer is completely removed by the oil wash. In this case, the entire surface can be cleaned with the oil instead of sanding.

If a clear oil has been applied after a colored oil application, the color may change in the event of damage, e.g. in the walkway area.

On surfaces that are already grayed, a darker color may appear after cleaning compared to the surrounding surface.
