Application Range Interior and exterior surfaces, coated with LIVOS stains and VINDO paints.

Technical Qualities Maintains and refreshes. Removes slight soiling leaving a subtle shine. Free of organic chemical

compounds according to DIN EN 71 part 9.

Full Declaration Isoaliphates, linseed oil, linseed oil-stand oil-natural resin ester, linseed oil-stand oil, orange oil,

dehydrated amino sugar, and drying agents free of lead (Mn, Zr).

Color Clear.

Application Use KALDET After Care, when coat is chalking, but shows no cracks yet or signs of strong weathering. Cover

masonry. Pour KALDET After Care on a cloth or sponge and wipe on. Remove splashes on windows

immediately or remove with SVALOS Thinner No. 22.

Coverage Depending on the different kind of surfaces. Determine the exact coverage by doing a test coat, if

necessary.

Drying Time At 23°C (73°F), 50% relative humidity: 2-8 hours. At higher temperatures, please consider shorter drying

times. At lower temperatures and higher humidity, please consider longer drying times.

Specific gravity Approximately 0.82 g/ml.

Important TipsThe interval of maintaining surfaces depends on many factors, e.g. if you detect slight chalking of the

coating layer or if the gloss should be refreshed. As a rule, once a year.

Ensure good ventilation during and after application. Always be sure to store and then dispose of cloths, polishing pads, sponges, etc. that are still wet or even slightly moist with KALDET After Care No. 276 in an airtight metal container or in water, as there is a danger of spontaneous combustion caused by the plant
