# BODIOS Toy Paint No. 343

<b>Application range</b>	For interior use, especially for toys made of softwood. Suitable for air brush application. Not for splash water areas, floors and countertops.			
<b>Technical qualities</b>	Water-based. Expressive colours - semi-transparent and matt. Wax-containing and polishable. Complies with German Industrial Norm DIN 53 160, fast to perspiration and saliva. Free from organic-chemical compounds according to DIN EN 71 part 9.			
<b>Full declaration</b>	Water, mineral pigments, polysaccharide, natural resin glycerin ester, beeswax soap, linseed oil, dammar, beeswax, methyl cellulose, larch resin, linseed oil stand oil, natural resin ester, shellac, silicic acid, castor oil - stand oil, isoaliphates, proteins, sodium carbonate, citric acid and sodium benzoate.			
<b>Colors</b>	005 Sunny yellow 041 English Red 201 White 445 Blue-violet All colors are intermixable.	011 Ochre 051 Persian Red 440 Linden green	018 Honey-yellow 066 Bramble Red 441 May green	020 Terracotta 101 Black 444 Capri blue
<b>Dilution</b>	Ready to use.			
<b>Application method</b>	Apply undiluted and sparingly, using a brush or sponge, at temperatures above 12 °C (54 °F) (see reverse side for further information).			
<b>Coverage</b>	1 liter (1.06 quart) is sufficient for approximately 15 - 20 m <sup>2</sup> (161 - 215 ft <sup>2</sup> ), i.e. 57 ml/m <sup>2</sup> . Coverage could be considerably less, depending on the condition and absorbency of the surface.			
<b>Drying time</b>	The drying time depends on the application quantity, temperature and humidity and can be up to 24 hours.			
<b>Cleaning</b>	Clean equipment immediately after use with LATIS Intensive Cleaner No. 551 or TRENA pH-Neutral Cleaner No. 556 - diluted with warm water.			
<b>Specific gravity</b>	Approximately 1.0 g/ml.			
<b>Safety advice</b>	P102 P301+P310 EUH208	Keep out of reach of children. IF SWALLOWED: rinse mouth. Do NOT induce vomiting. Immediately call a doctor. Contains limonene (orange oil). May produce an allergic reaction.		
<b>Disposal</b>	According to locally regulated laws.			
<b>Container sizes</b>	0.05 l; 1.0 l; 2.5 l.			
<b>Storage</b>	Cool, dry, and frost-free. Shelf life: unopened at least 4 years. Close lid tightly after use.			
<b>Packaging</b>	Made of polyethylene (PE). This material is ground water neutral and recyclable.			

How to use

## **BODIOS Toy Paint No. 343**

<b>Preparation</b>	The wood must be dry, solid, absorbent, finely sanded (at least 220 grain), free of resin and dust.
<b>Application</b>	Shake or stir product thoroughly before use. Apply sparingly and evenly in the direction of the wood grain. After 5 – 60 minutes, polish with a cotton cloth or natural brush (sisal / leather). If the coating thins out during the polishing process, reduce the polishing pressure or extend drying times. Always do a test application first. Possible defects and flaws will become visible during the polishing process.
<b>Follow-up treatment</b>	For higher resistance we recommend a follow-up treatment with BODIOS Protection No. 344 (without tendency to yellowing).
<b>Cleaning and Care</b>	Light soiling can be removed with TRENA pH-Neutral Cleaner No. 556, diluted 1:5 with water. After-treatment by coating the entire surface with BODIOS Toy Paint No. 343.  Traces of usage can be removed by slightly sanding and new treatment with BODIOS Toy Paint No. 343.
<b>Important tips</b>	Especially lively and expressive effects can be created with the help of wiping techniques such as sponging, while blending different shades of BODIOS.
